Monday, May 11, 2026 Deadline is extended because of weekend.	May monthly activities report (all lobbyists filing monthly)	April 1, 2026, <u>or</u> January 1, 2026, if first activities report*	April 30, 2026
Wednesday, June 10, 2026	June monthly activities report (all lobbyists filing monthly)	May 1, 2026, or January 1, 2026, if first activities report*	May 31, 2026

^{*} If you file your initial lobby registration after January 1, 2026, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2026, that registrant's first monthly report (due by April 10, 2026) would cover the period beginning January 1, 2026, and ending March 31, 2026. *Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.*

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps**.

^{*} If you file your initial lobby registration after January 1, 2026, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2026, that registrant's first monthly report (due by April 10, 2026) would cover the period beginning January 1, 2026, and ending March 31, 2026. *Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.*
