*The following numbers correspond to the numbered boxes on the other side.*

1. **Registrant Name.** Enter your name.
2. **Is Registrant an Entity?** Check the appropriate box.
3. **Contact Name if Registrant is an Entity.** Enter the name of an individual who will serve as a contact person for the Texas Ethics Commission if the registrant is an entity.
4. **Registrant Mailing Address.** Enter the address of the registrant requesting the password. The Ethics Commission will mail the official password by certified mail to the address provided.
5. **Registrant Telephone Number.** Enter the telephone number of the registrant requesting the password, including the area code and, if applicable, the extension number.
6. **Registrant Signature.** Sign after reading the statement.
7. **Lobbyist Name Change.** If you have an existing Lobby Filer ID with the Ethics Commission and you desire to change the way your name appears in the Ethics Commission records, enter:
  - Filer ID.** Enter the registrant Filer ID assigned by the Ethics Commission.
  - Current Name.** Enter the Registrant name as it is currently listed with the above Filer ID in the Ethics Commission records.
  - New Name.** Enter the new name you wish to have registered with this Filer ID.
